# **StockTakeRx Privacy Policy**

This Privacy Policy applies between you, the user of the Website/Services (as such terms are defined in the StockTakeRx Licence Agreement and Conditions of Use), and us, Drug Tariff Pro Ltd, a limited company with company number 15673972 (hereinafter referred to by the trading name "StockTakeRx"), the owner and provider of the Website.

We take the privacy of your information very seriously. This Privacy Policy applies to our use of any and all Personal Data collected by us or provided by you in relation to your use of the Website/Services.

#### Please read this Privacy Policy carefully.

- 1. Definitions and Interpretation
  - 1.1. "**Cookies**" shall mean the small text files placed on your computer or device when you visit certain parts of the Website and/or when you use certain features of the Website;
  - 1.2. "**Data Controller**" shall have the meaning ascribed to it in the applicable Data Protection Laws;
  - 1.3. "**Data Processor**" shall have the meaning ascribed to it in the applicable Data Protection Laws;
  - 1.4. "Data Protection Laws" shall mean any laws relating to the processing of Personal Data, including but not limited to the General Data Protection Regulation as implemented in the United Kingdom through the Data Protection Act 2018 (hereinafter "GDPR") and any other national implementing and supplementary laws, regulations and secondary legislation;
  - 1.5. "**Data Subject**" shall have the meaning ascribed to it in the applicable Data Protection Laws;
  - 1.6. "**Personal Data**" shall have the meaning ascribed to it in the applicable Data Protection Laws;
  - 1.7. "UK and EU Cookie Law" shall mean the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011 and the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2018;
  - 1.8. "**you**" and "**your**" shall mean any third party that accesses, uses and/or subscribes to the Website unless that third party is subject to terms agreed with us which expressly override the terms of this Privacy Policy;
  - 1.9. "Website" shall mean www.drugtariffpro.com and any subdomains of such site unless expressly excluded by their own terms and conditions;

#### 1.10. "we", "our" and "us" shall mean StockTakeRx.

#### 2. Background

For purposes of this Privacy Policy, unless the context requires a different interpretation:

- 2.1. The singular shall include the plural and vice versa;
- 2.2. References to subclauses, clauses, schedules and appendices are to subclauses, clauses, schedules and appendices of this Privacy Policy unless otherwise specified;
- 2.3. References to "person" shall include natural persons and legal persons such as firms, companies, government entities, organisations, trusts and partnerships;
- 2.4. The term "including" shall mean "including but not limited to";
- 2.5. References to any statutory or regulatory provision shall include any and all modifications and amendments to it;
- 2.6. The headings and subheadings to this Privacy Policy shall not form part of this Privacy Policy.
- 3. Scope
  - 3.1. This Privacy Policy applies only to the actions of us and you. It does not apply to websites owned and controlled by third parties, including websites that can be accessed through links provided on the Website. You are advised to read the privacy policies and/or statements of other websites prior to using them.
  - 3.2. For purposes of the applicable Data Protection Laws, we are the Data Controller and the Data Processor (except where a third party data processor is used as set out in this Privacy Policy) and you are the Data Subject. We will determine the purposes for which and the manner in which your Personal Data is processed and will collect and process such Personal Data in accordance with the applicable Data Protection Laws.
- 4. Personal Data Collected
  - 4.1. We may collect the following Personal Data from you:
    - 4.1.1. Full name;
    - 4.1.2. Contact information such as business name and address, email address, and telephone number;
    - 4.1.3. Job role;
    - 4.1.4. Financial information such as debit and/or credit card details;

in each case, in accordance with this Privacy Policy.

#### 5. Manner of Collection

- 5.1. We may collect Personal Data in the following ways:
  - 5.1.1. Personal Data is given to us by you, such as:
    - 5.1.1.1. When you contact us through the Website, or by telephone, post, email or any other means;
    - 5.1.1.2. When you set up an account to use the Website/Services;
    - 5.1.1.3. When you subscribe for a payment plan to use the Website/Services;
    - 5.1.1.4. When you make payments to us, through the Website or otherwise; and
    - 5.1.1.5. When you elect to receive marketing communications from us,

in each case, in accordance with this Privacy Policy.

- 5.1.2. Personal Data is collected automatically. We automatically collect some information about your visit to the Website. This information is collected to help us make improvements to the Website content and navigation, and may include:
  - 5.1.2.1. Your IP address;
  - 5.1.2.2. The date, times and frequency of your access to the Website; and
  - 5.1.2.3. The way you use and interact with the content on the Website,

in each case, in accordance with this Privacy Policy.

## 6. Cookies Policy

- 6.1. The Website may place and access certain Cookies on your computer or device. We use Cookies to improve your experience of using the Website and to improve our range of Services. We have carefully chosen these Cookies and have taken steps to ensure that your privacy is protected and respected at all times.
- 6.2. All Cookies used by this Website are used in accordance with current UK and EU Cookie Law.
- 6.3. Before the Website places Cookies on your computer or device you will be presented with the message bar requesting your consent to set those Cookies. By giving your consent you are enabling us to provide a better experience and service to you. You may, if you wish, deny consent to the placing of certain Cookies, but if you do so then certain features of the Website may not function fully or as intended.
- 6.4. The Website may place the following Cookies:

#### 7. Processing of Personal Data

- 7.1. Any or all of the Personal Data collected as described above may be used by us from time to time in order to provide you with the best possible service and experience when using the Website/Services. This may include:
  - 7.1.1. Internal record keeping;
  - 7.1.2. Improvement of the Website and our Services;
  - 7.1.3. Transmission by email of marketing materials that may be of interest to you;
  - 7.1.4. Contact for research purposes, which may be done using email, telephone, fax, mail or any other means, which information may be used to update or customise the Website,

in each case, in accordance with this Privacy Policy.

- 7.2. We may use your Personal Data for the purposes set out in Clause 7.1 above if it is deemed necessary for the legitimate interests of StockTakeRx. If you are not satisfied with the use of your Personal Data in this way, you have the right to object under certain circumstances, as set out in Clause 11 below.
- 7.3. For the delivery of direct marketing to you via email, we will require your consent, whether by opt-in or soft-opt-in, as follows:
  - 7.3.1. A soft-opt-in consent applies when you have previously engaged with the Website (for example, you have previously agreed to receive marketing information and we are now sending similar marketing information). In such circumstances we will take your consent as given unless you opt out.
  - 7.3.2. For other types of marketing, we will require your express consent, meaning you need to take an affirmative step to give consent by, for example, checking a tick-box that we provide on the Website.

  - 9.1.3. Payment details are encrypted using SSL technology.
- 9.2. Technical and organisational measures include measures to handle any suspected data breach. If you suspect any misuse or loss of, or unauthorised access to, your Personal Data, please let us know immediately by contacting **support@drugtariffpro.com**.
- 9.3. #### 10. Personal Data Retention

- 10.1. Unless a longer period is required or permitted by law, we will only hold your Personal Data for the period necessary to fulfil the purposes outlined in this Privacy Policy or the purposes for which the particular Personal Data is collected until you request that your Personal Data be deleted.
- 10.2. Once your Personal Data has been deleted by us it may persist on backup or archival media for legal, tax or regulatory purposes.

## 11. Your Rights

- 11.1. In connection with the collection and processing of your Personal Data, you have the following rights:
  - 11.1.1.1. **Right to access**, which includes the right to request:

- 11.1.1.1.1. Copies of the Personal Data we hold about you at any time; and/or
- 11.1.1.1.2. Modifications, updates and/or deletions of such Personal Data.

If we provide you with access to the Personal Data held about you, you will not be charged for this unless your request is manifestly unfounded or excessive. Where legally permitted to do so we may refuse your request, and if your request is refused you will be told the reasons why.

- 11.1.1.2. **Right to correct**, which is the right to have your Personal Data rectified or altered if it is inaccurate or incomplete.
- 11.1.1.3. **Right to erase**, which is the right to request that we delete or remove your Personal Data from our systems.
- 11.1.1.4. **Right to restrict the use of your Personal Data**, which is the right to block us from using your Personal Data or to limit the way in which your Personal Data can be used.
- 11.1.1.5. **Right to data portability**, which is the right to request that we move, copy or transfer your Personal Data.
- 11.1.1.6. **Right to object**, which is the right to object to our use of your Personal Data including where it is used for our legitimate interests.
- 11.2. To make enquiries, exercise any of your rights set out above, or withdraw your consent to the processing of your Personal Data (where consent is the legal basis for processing your Personal Data), please contact **support@drugtariffpro.com**.
- 11.3. If you would like to delete your account on the Website including your Personal Data associated with it, please contact **support@drugtariffpro.com** to request this.
- 11.4. If you are not satisfied with the way in which a complaint you make in relation to your Personal Data is handled by us, you may be able to refer your complaint to the relevant data protection authority. - 11.5. It is important that the Personal Data we hold about you is accurate and current. Please keep us informed if your Personal Data changes during the period for which it is held.
- 12. Changes of Business Ownership and Control
  - 12.1. We may from time to time expand or reduce business operations and this may involve the sale and/or transfer of control of all or part of StockTakeRx. Personal Data provided by you will, where it is relevant to any part of the business so transferred, be transferred along with that part of the business and the new owner

and/or newly controlling party shall, under the terms of this Privacy Policy, be permitted to use the Personal Data for the purposes for which it was originally supplied to us, unless or until you withdraw your consent.

- 12.2. We may also disclose Personal Data to a prospective purchaser of the business and/or any part of it where there is a legal basis to do so.
- 12.3. In relation to Clauses 12.1 and 12.2 above, we will take appropriate steps with the goal of ensuring Your privacy is protected.

#### 13. General

- 13.1. You may not transfer any of your rights under this Privacy Policy to any other person. We may transfer our rights under this Privacy Policy where legally permitted to do so and where we reasonably believe that your rights will not be affected.
- 13.2. If any court or competent authority finds that any provision (or part of any provision) of this Privacy Policy is invalid, illegal or unenforceable, that provision (or part of it) shall, to the extent required, be deemed deleted and the validity and enforceability of the remaining provisions of this Privacy Policy shall not be affected.
- 13.3. Unless otherwise agreed, no delay, act or omission by any party in exercising any right or remedy in connection with this Privacy Policy shall be deemed a waiver of that or any right or remedy.
- 13.4. This Privacy Policy shall be governed by and interpreted in accordance with the laws of England, and any and all disputes arising under this Privacy Policy shall be subject to the exclusive jurisdiction of the courts of England.
- 13.5. This Privacy Policy shall be deemed incorporated by reference into the StockTakeRx Licence Agreement and Conditions of Use which you will be asked to accept in order to use the Website/Services. To the extent that there is any express conflict between the terms of the StockTakeRx Licence Agreement and Conditions of Use and the terms of this Privacy Policy, the terms of this Privacy Policy shall prevail unless otherwise expressly stated.
- 14. Changes to this Privacy Policy
  - 14.1. We reserve the right to change this Privacy Policy unilaterally as we may deem necessary from time to time or as may be required by law.
  - 14.2. Any changes to this Privacy Policy will be promptly posted on the Website and we will notify you via available contact information which you have provided. You are deemed to have accepted the terms of the Privacy Policy on your first use of the Website following the changes.
